Easy 4-step set-up

- ① Open WeChat and scan the QR code of HSBC China Corporate Banking WeChat Service Account
- ② Click on "user binding" in the menu and select "trade user binding"
- ③ Read and accept "terms and conditions"
- ④ Enter your HSBC Trade Account number, Instant@dvice email address, bill or DC reference number and the confirmation code provided to your email address. To unbind, follow the required steps in the menu.
